Yet infrastructure limitations—poor internet access, low smartphone penetration—hinder mass adoption, highlighting the digital divide that shapes technological equity. These contrasts underscore Glow's dual nature: a global prototype, yet deeply contextual in its impact. Its success depends not just on innovation, but on cultural fluency and infrastructural readiness.
