This reframing shifted policy debates, pushing security analysts to consider geography not as a fixed backdrop but as a fluid contested arena. Geopolitically, Husain's work gained urgency amid the rise of China's Belt and Road Initiative (BRI) and India's Act East policy. He was among the first to analyze the China-Pakistan Economic

Corridor (CPEC) not just as an infrastructure project but as a spatial reordering—redirecting trade flows from traditional maritime routes through Gwadar Port into inland industrial zones, thereby altering regional power geometries. His 2016 monograph, ‘Silk Roads Reimagined: Geopolitical Spatiality in the Digital Age,’ argued that 21st-century corridors were not just physical but digital, with data centers, fiber-optic lines, and surveillance networks forming new layers of territorial control. He warned of the “digital colonialism” embedded in BRI’s tech infrastructure, where connectivity could deepen dependency rather than empower local agency. Economically, Husain’s critique targeted the myth of spatial neutrality in global value chains. He demonstrated how multinational corporations exploit jurisdictional arbitrage—using special economic zones, tax havens, and lax environmental regulations—to externalize costs onto vulnerable communities. His research on textile clusters in Lahore and Karachi revealed a geography of exploitation: polluted rivers, child labor in factory outskirts, and carbon-intensive logistics—all hidden in corporate sustainability reports. By overlaying satellite imagery with labor data and migration patterns, he exposed the invisible geographies of global supply chains, forcing a reckoning with the spatial ethics of production. Industry responses were mixed. While some

industrialists dismissed his work as overly critical, others embraced his frameworks for risk assessment and stakeholder engagement. Multinational firms began integrating his “spatial justice” metrics into CSR strategies, recognizing that long-term viability depended not just on cost efficiency but on equitable spatial outcomes. His advocacy for “participatory cartography”—where local communities co-produce maps of their own territories—was adopted by NGOs and UN agencies in disaster resilience planning, particularly in flood-prone Sindh and Balochistan. Yet Husain’s work was not without controversy. Critics from state bureaucracies accused him of “geopolitical exaggeration,” particularly his framing of Pakistan’s border regions as zones of sovereign ambiguity.
