Multinational seafood corporations, often headquartered in wealthier nations, source from distant waters through opaque supply chains. Their profit models rely on low regulatory oversight and labor exploitation, particularly in developing nations where labor laws are weakly enforced. The true cost of this system—ecological degradation, social displacement, and long-term economic fragility—is systematically externalized, subsidized by public funds, or ignored in shareholder reports.
