This holistic approach reflected a broader industry shift: from isolated automation tools to integrated, intelligent manufacturing platforms. The manual's publication coincided with the launch of the Industrial Internet Consortium (IIC) initiative in the U.S., signaling a nascent global consensus on standardizing cyber-physical systems. Yet while American and European firms debated interoperability frameworks, Auris pursued a different path—one rooted in proprietary innovation tempered by cross-industry collaboration.
