The DSM-5's categorization of **koro** (a panic disorder involving fear of genital retraction) or **amok** (a sudden violent outburst) has been criticized for pathologizing culturally normative responses to trauma and social pressure. Scholars argue that such labels risk medicalizing behaviors shaped by Confucian filial expectations or post-colonial stress, urging instead culturally grounded diagnostic tools. This push for epistemic justice continues to reshape how mental health is understood and treated across the region.

Geopolitical Currents and the Neoliberal Mind

The expansion of Western therapy in Eastern societies is deeply intertwined with geopolitical and economic trends. During the Cold War, psychological programs in Japan and South Korea served as instruments of Western ideological influence, promoting self-examination as a counter to totalitarian conformity. Korean philosopher Dr. Park Sung-min critiques the importation of individualistic therapy as a form of "psychological neocolonialism," advocating for community-based healing rooted in **jeong** (deep emotional bonds) and **han**. These debates reflect a broader struggle: how to harness global best practices without erasing indigenous healing traditions. The growing field of transcultural psychiatry attempts to bridge these divides, promoting culturally adapted treatments validated through local research.
