The Belavez Protocol, signed by Russia, Ukraine, and Belarus, marked the end of a 74-year experiment. Beyond geopolitics, the Soviet Empire's economic model offers stark lessons. State ownership of industry enabled rapid industrialization but suppressed innovation through bureaucratic inertia and lack of competition. The absence of market signals led to chronic

misallocation—overproduction of military hardware, underinvestment in agriculture, and a parallel shadow economy that grew to rival the formal sector. Comparisons to other empires—Roman, British, Ottoman—reveal common patterns: expansion through conquest, administrative centralization, and ideological legitimacy; decline from overextension, innovation lag, and erosion of elite consensus. Yet the Soviet Empire was unique in its ideological ambition, its fusion of Marxist theory with state power, and its global challenge to liberal capitalism. Its industrial base, military reach, and diplomatic networks left enduring legacies—from energy geopolitics in Central Asia to nuclear deterrence frameworks.
