Multilateral bodies like UNESCO and the OECD are well-positioned to foster such frameworks. The long-term societal impact extends beyond knowledge acquisition. As youth grow up engaging with constitutions as living, participatory documents, they internalize civic agency—transforming passive rights into active responsibilities. This generational shift could strengthen democratic resilience, counter authoritarianism, and deepen social cohesion in increasingly polarized worlds. However, the movement’s legacy will
