In Belarus, where independent media were shuttered after the 2020 election, exiled journalists use secure communication tools to publish verified reports from abroad, often relying on crowdsourced documentation and satellite imagery to corroborate human rights abuses. In Kazakhstan, where the 2022 protests were met with violent crackdowns, journalists operate from neighboring countries, aggregating social media content and eyewitness

accounts while avoiding digital surveillance. The test's global diffusion reveals a stark asymmetry. In
