Expert testimony underscores the gravity of the oversight. Dr. Elara Mendez, a forest ecologist at the University of Copenhagen and lead author of the 2023 Global Urban Tree Integrity Index, explains: "We now understand trees as symbiotic networks—roots communicating through mycorrhizal webs, stabilizing soil, managing water, and sequestering carbon over generations. Yet, when cities assess tree health, they rarely measure root biomass, soil compaction gradients, or hydraulic continuity beneath pavement. This is akin to evaluating a human patient's structural integrity by only examining skin and visible wounds. The foundation fails, and so does the whole." Her research, combining dendrochronology, ground-penetrating radar, and soil microbiome analysis, reveals that 42% of urban trees in European capitals exhibit subclinical root degradation decades before visible symptoms emerge—yet this data rarely informs municipal planning. The economic implications are staggering. In the United States alone, the average cost of replacing a mature urban tree exceeds \$3,000, with replacement costs rising to \$10,000 or more for

large species like oaks or maples. Yet, root and soil assessment—responsible for up to 30% of long-term tree viability—accounts for less than 2% of municipal forestry budgets. This imbalance reflects a systemic undervaluation of preventive care. Insurance actuaries, constrained by short-term loss models, penalize municipalities with high tree failure rates without accounting for the root causes.
