Meanwhile, the Soviet Union exploited anti-colonial sentiment, backing nationalist movements and socialist experiments—particularly in Egypt under Nasser, whose pan-Arab vision challenged Western dominance. This ideological tug-of-war entrenched authoritarianism in many states, as regimes used foreign patronage to suppress internal dissent and consolidate power. The discovery and exploitation of hydrocarbons from the 1930s onward irreversibly altered the region's political economy. Oil became not just a commodity but a strategic asset, transforming nascent states into rentier economies where state legitimacy often hinged on the distribution of resource wealth rather than democratic accountability. The Gulf

monarchies—Saudi Arabia, Kuwait, the UAE—leveraged oil revenues to build centralized, dynastic states, their political systems insulated from popular mandates by a combination of patronage, tribal allegiance, and controlled political participation. In contrast, states like Iran, Iraq, and Libya saw oil catalyze revolutionary upheaval, with control over resources becoming a central axis of power and conflict. The 1979 Iranian Revolution marked a tectonic shift. The establishment of a theocratic state under Ayatollah Khomeini challenged both Western influence and the regional status quo, introducing a model of governance rooted in Shiite Islamist ideology. This ideological divergence deepened the Sunni-Shia fault line, transforming sectarian identity from a matter of theology into a geopolitical fault line. The Iran-Iraq War (1980–1988), fueled by competing visions of regional leadership and sectarian polarization, exemplified how religious identity could be weaponized in state rivalry. The conflict left Iraq economically devastated and Saddam Hussein's regime emboldened, setting the stage for future interventions and regional destabilization. Yet internal fissures have emerged, most starkly during the 2017 Qatar blockade, when Saudi Arabia, UAE, Bahrain, and Egypt severed ties with Doha over allegations of support for extremism and alignment with Iran. The crisis exposed the fragility of regional unity, even among allies, and underscored how ideological and strategic differences can fracture formal alliances. Energy geopolitics continues to shape the region's political map. The Gulf states, particularly Saudi Arabia and the UAE, are investing

aggressively in economic diversification—what they term “Vision 2030” and similar initiatives—to reduce dependence on oil amid global energy transitions. These efforts include mega-projects like NEOM, renewable energy investments, and financial diplomacy aimed at securing influence beyond hydrocarbons. Yet this diversification coexists with persistent political authoritarianism, raising questions about long-term stability when economic modernization outpaces political reform. The Kurdish question remains one of the most intractable territorial disputes. Spanning parts of Turkey, Iraq, Syria, and Iran, Kurdish aspirations for autonomy or independence have been repeatedly suppressed, yet their military and political agency—especially through the YPG in Syria and Peshmerga in Iraq—has altered regional dynamics. The mandate system formalized these divisions: Britain governed Iraq and Palestine under League of Nations mandates, imposing administrative structures that prioritized colonial oversight over indigenous state-building. These borders were not drawn with reference to historical kingdoms, tribal territories, or trade networks but with an eye to resource control—particularly oil, which was discovered in abundance in the 1920s and quickly became the cornerstone of imperial economic strategy. The artificial nature of these boundaries sowed the seeds of instability. Tribal confederations

spanned modern borders; sectarian communities were divided or forced into uneasy coexistence. In Palestine, the Balfour Declaration's endorsement of a Jewish homeland clashed with Arab nationalist aspirations, embedding a conflict of identity that would erupt violently in the decades to come. The Hashemite dynasties, installed by Britain in Iraq and Transjordan, were foreign actors accepted not through popular mandate but colonial design, their legitimacy repeatedly questioned by local populations. This imposition of borders was reinforced by the broader logic of imperial administration—divide and rule, indirect governance through local elites, and suppression of nationalist movements. The map thus emerged not from negotiation among regional actors but from the dictates of external powers, a map that would outlive empires yet remain deeply incompatible with the region's socio-political fabric.
