Meanwhile, the EU's push for a digital euro and digital euro area integration aims to strengthen European autonomy. The role of forex in global governance will evolve. The IMF's SDR may gain broader reserve currency status if trust in the dollar wanes—though structural inertia and U.S. policy remain barriers. Multilateral coordination on exchange rate transparency, speculative position limits, and crisis prevention mechanisms will become more urgent to prevent competitive devaluations and financial contagion.
