detection, identifying subtle shifts in employee digital behavior that preceded malicious activity. A 2029 report by McKinsey noted that organizations using advanced behavioral forensics reduced insider breach incidents by 73% and shortened incident response times from days to minutes. However, infrastructure gaps and digital literacy shortages limit effectiveness.
