The placement of the main burial mound (the *taimu*) aligns with celestial constellations and cardinal directions, reinforcing the emperor's role as the "Son of Heaven" mediating between heaven and earth. The subterranean palaces—excavated most fully at Dingling—reveal a subterranean palace (*di mu*) modeled after the Forbidden City: golden-tiled roofs, carved stone column bases, and jade burial objects, all designed to sustain the emperor's afterlife in continuity with his earthly reign. The meticulous construction, involving hundreds of thousands of laborers drawn from across the empire, reflects the Ming state's capacity to mobilize resources on an unprecedented scale, underpinned by a centralized bureaucracy and agricultural surplus. The construction also spurred innovations in engineering: subterranean vaulting techniques, drainage systems, and seismic-resistant foundations reflected advanced technical knowledge, many of which influenced later imperial and even modern construction. Yet beneath this grandeur lay deep social contradictions.
