Each track, though standalone, functioned as a node in a larger constellation, demanding active listening and contextual immersion. The geopolitical context of **Preludes** cannot be overstated. Its creation coincided with a global moment of rising authoritarianism, austerity, and cultural erasure. The 2010s saw the intensification of IMF-backed structural adjustment programs across Latin America, the criminalization of protest in Venezuela, the dismantling of social safety nets in Puerto Rico after Maria, and the weaponization of media narratives in migration crises. Delgado’s work emerged as both response and resistance—sonic counter-mapping that challenged the homogenizing forces of neoliberal modernity.
