Yet in 2022, a minor annotation shift in a 3D model led to a connection misalignment, delaying assembly by weeks. The root cause? A British design firm used a line style convention unfamiliar to French welders, whose manual interpreted a dashed line as a tolerance boundary rather than a guidance mark. This incident underscores a critical insight: engineering drawing language is not universal. It is a cultural artifact, shaped by professional norms and institutional memory. The rise of generative design compounds these challenges. Unlike traditional drafting, where engineers iteratively refine
