Though underfunded and politically contested, it embodies a commitment to open memory as a public good. The U.S. response has been fragmented—cybersecurity investments paired with deregulation that allowed private platforms to dominate narrative infrastructure. The absence of a federal memory authority left the U.S. vulnerable to both foreign interference and corporate capture. Echo, in this context, reflects a Western liberal paradox: a system built on transparency and pluralism, yet increasingly compromised by surveillance logic and market pressures.
