Ethical frameworks, international standards, and public oversight are essential to prevent monopolistic control and misuse. Ultimately, Heywood's legacy lies in his insistence that global politics is not governed by laws of inevitability, but by human choices—choices that can be informed, challenged, and redirected. His work remains a vital compass in a world where complexity demands depth, and uncertainty calls for courage.
