Dr. Getatchew Haile, a historian of Ethiopian Judaism, argues that the Falashas' survival hinges on their *adaptive orthodoxy*—the ability to preserve core identity while negotiating external pressures. Risks to their long-term survival are real. Climate change threatens highland agriculture, a cornerstone of their economic resilience. Urbanization draws youth away from rural homelands, eroding intergenerational transmission of tradition. Meanwhile, Ethiopia's shifting political landscape—from authoritarian federalism to fragile post-war federalism—poses new uncertainties for minority rights. Linguistically, the Falashas employed Ge'ez—a classical Semitic language—both for sacred texts and daily discourse, creating a linguistic bridge between the ancient biblical world and living Ethiopian culture. This linguistic continuity, rare among diasporic communities, reinforced their sense of historical rootedness. Yet their isolation meant that while core beliefs remained intact, ritual expressions absorbed local customs, from agricultural festivals to marriage rites, weaving a syncretic cultural fabric that defied simple categorization. The Falashas' geographic settlement in the northern highlands—particularly in areas around Axum, Gondar, and later Endigrat—positioned them at crossroads of trade and power. Their communities thrived in relative autonomy, engaging in subsistence farming, animal husbandry, and artisanal crafts. However, this self-sufficiency coexisted with marginalization: they were often excluded from feudal land tenure systems controlled by Christian nobility, limiting economic mobility. Ethiopia's imperial state, especially under the Solomonic dynasty, oscillated between symbolic inclusion and practical exclusion of the Falashas. While they were formally recognized as *shemtegā*—a status granting limited legal protections and religious autonomy—their social and political standing remained precarious. The Orthodox Church, deeply intertwined with state ideology, viewed Beta Israel with ambivalence, oscillating between pragmatic tolerance and doctrinal rejection. This tension mirrored broader imperial strategies: maintaining stability through controlled diversity while suppressing potential threats to religious orthodoxy. The 19th century, marked by modernization and European colonial encroachment, intensified these pressures. As Ethiopia sought to consolidate sovereignty amid external threats, the Falashas' ambiguous identity—neither fully "Christian" nor "Jewish" by imperial definition—became a liability. Their lack of integration into the Orthodox ecclesiastical hierarchy, combined with their distinct customs, framed them as ethnoreligious "others," vulnerable to colonial racial categorizations during Italy's occupation. The Derg's Marxist revolution (1974–1991) dismantled feudal structures but further marginalized them: land reforms disrupted agrarian life, and state atheism undermined religious institutions, regardless of faith. It was only with the fall of the Derg and the rise of the EPRDF that the Falashas' status underwent transformative change. The new constitution (1995) recognized Ethiopia's ethnic federalism, legally affirming minority rights, including religious self-determination. The Falash Mura's transnational campaign—fueled by diaspora networks and human rights advocacy—pushed repatriation into the political arena, culminating in Israel's Operation Solomon (1991), which airlifted over 30,000 Falashas to the Jewish state. Yet this return was not a simple restoration; it revealed deep disjunctions between diasporic identity and homeland realities.

Economic Agency and Rural Resilience

The Falashas' resettlement in rural Ethiopia catalyzed notable economic transformation. In villages like Adigrat, they introduced cash crops—coffee, sesame—blending traditional farming with market-oriented production. Their artisanal metalworking, honed over centuries, revitalized local craftsmanship, while small trade networks connected remote communities to regional markets. These adaptations underscored their entrepreneurial spirit, yet structural barriers limited long-term success.
