A South African energy minister, for instance, excelled not in budgetary mastery but in mediating between community protest, environmental NGOs, and foreign investors—balancing urgency with legitimacy. This insight validated the need for a more holistic, context-sensitive assessment. By 2016, the first LLQP pilot was launched with 12 national civil services and 20 global firms.
