British officers were trained in European policing doctrines, importing concepts like forensic investigation and surveillance techniques, yet these were deployed selectively, with indigenous policing traditions either co-opted or suppressed. The colonial model prioritized stability over justice, embedding a legacy of impunity and distrust that persists in post-independence institutions. After independence in 1947, India inherited a policing structure deeply marked by colonial trauma. The new Republic faced the dual challenge of unifying a vast, pluralistic nation while dismantling the instruments of repression. The Constitution, in Article 246 and through the establishment of state-level police forces under the Seventh Schedule, affirmed federalism in policing, yet centralized oversight via the Ministry of Home Affairs retained significant influence. The Police Act of 1861 remained the legal bedrock, albeit amended multiple times—most notably in 2006 with the Police Reform and Development Act, which sought to professionalize forces, enhance accountability, and integrate gender and human rights sensitivities. Yet the post-colonial state struggled with structural contradictions. Policing became a tool for both nation-building and political control. In the early decades, police played a key role in maintaining communal harmony during partition, but also suppressed leftist movements, Naxalite uprisings, and regional separatist struggles—often through coercive tactics that eroded public trust. The Armed Forces (Special Powers) Act (AFSPA), originally deployed in tribal regions and later extended to conflict zones like Jammu and Kashmir, exemplifies this shift: granting sweeping powers under the guise of national security while evading civilian oversight. Human rights groups document systemic abuses—excessive force, enforced disappearances, and sexual violence—with inadequate redress mechanisms. Gender and caste dynamics further reveal policing's embedded inequalities. The United States model, with its decentralized, militarized law enforcement, offers a cautionary parallel in racial polarization and gun violence; yet India's unique federal structure, religious diversity, and economic informality create distinct challenges. In contrast, Nordic models emphasize de-escalation and community trust—principles only nascent in India's reform efforts. Looking forward, technological transformation is reshaping policing. AI-driven predictive policing, facial recognition, and digital forensics promise efficiency but risk amplifying bias and surveillance overreach. The 2021 Supreme Court directive mandating transparency in AI use marks a critical step toward regulation. Meanwhile, grassroots movements demand civilian oversight, community policing pilot programs, and the integration of restorative justice practices. The long-term implications hinge on institutional legitimacy. Without meaningful

reform—decolonizing training, democratizing oversight, and aligning mandates with human rights—the police risk deepening alienation in a democracy already strained by polarization. India’s unique context—pluralism, federalism, and developmental pressures—complicates direct replication of foreign models. Yet, lessons abound: Sweden’s emphasis on de-escalation training, Singapore’s use of technology with oversight, and Canada’s civilian review boards offer pathways for reform. The key lies not in copying, but in adapting principles to local realities—prioritizing human rights, community engagement, and legal accountability. The long-term implications of current trends are profound. Without meaningful change, public trust in policing will continue to erode, fueling vigilantism, social fragmentation, and political instability. Conversely, a reformed model—transparent, accountable, and rights-respecting—could strengthen democratic resilience, fostering safer, more inclusive communities.

The future of Indian policing hinges on three interlocking trajectories: technological integration, institutional reform, and societal mobilization.
