Conversely, county administration insists the current system maintains accountability and consistency. Director of Human Resources, Thomas Holloway, argues: "We test for core competencies—ethics, procedural knowledge, communication—foundations no algorithm can replace. Flexibility risks diluting standards." This stance reflects a deeper tension: between democratizing access and preserving institutional rigor. Candidates could build digital portfolios, demonstrating skills through real-world tasks—such as drafting a public service announcement or managing a mock crisis response. This aligns hiring with job performance and accommodates diverse learning trajectories. Second, ****lifelong learning integration**** is essential. ERIE's 2025 pilot program for "micro-credentials" in public tech and policy offers a blueprint. By linking exam performance to ongoing training, the county can foster agility—turning hiring into a continuous development cycle. Third, ****equity-centered design**** must anchor reform. Bilingual exams, community-based prep hubs, and targeted outreach to underserved groups will reduce disparities. The success of similar initiatives in Houston's public administration division suggests such investments yield higher

retention and public trust. Economically, a modernized civil service could unlock significant value. A 2024 McKinsey study estimates that improving public sector workforce readiness could boost productivity by 15–20% in mid-sized cities, reducing service delivery costs and enhancing citizen satisfaction. For Erie, where governance challenges are acute, this translates to tangible improvements in infrastructure, healthcare access, and economic competitiveness.
