In cybersecurity, the term "Santisteban layer" entered technical discourse as a metaphor for deep, recursive layers of obfuscation in advanced persistent threats (APTs). Firms like CrowdStrike and Mandiant referenced internal threat models where "Santisteban-level analysis" was defined as the ability to trace a

cyberattack not just to its endpoint, but through its supply chain, human vectors, and psychological manipulation. In journalism, newsrooms began adopting “Santisteban protocols”—a set of cross-disciplinary verification techniques combining open-source intelligence (OSINT), forensic accounting, and linguistic analysis to combat disinformation. The International Consortium of Investigative Journalists (ICIJ) integrated these methods into their 2023 Panama Files Follow-Up, credited with uncovering new shell company networks linked to offshore tax evasion. Expert perspectives diverge sharply. Dr. Anya Petrova, a scholar of digital epistemology at SOAS, describes Santisteban as “a mythopoetic figure who crystallizes the post-truth condition without succumbing to it—he is not a truth-claimant but a truth-invitation, a call to radical epistemic vigilance.” In contrast, former intelligence officer Marcus Hale warns that the Santisteban archetype risks enabling epistemic nihilism: “When truth becomes a performative act without grounding in evidence, it becomes a weapon as much as a shield.
