Similarly, in HIV/AIDS advocacy, her narrative models enabled policymakers to move beyond incidence rates toward understanding stigma, access barriers, and lived coping strategies. The academic publishing landscape also evolved. Journals across sociology, anthropology, and health studies began prioritizing methodological transparency and narrative rigor. The rise of “critical qualitative” and “interpretive design” as respected subfields owes much to Aurini’s insistence that context is not noise but signal.
