The 2020 Tokyo Olympic Village, constructed largely from glulam and CLT, demonstrated timber's performance in high-density, earthquake-prone environments. Chappell notes that Japan's Forest Agency mandates that 30% of post-disaster reconstruction use engineered timber, fostering a national standard that integrates traditional joinery with modern engineering. In contrast, China's timber industry remains anchored in mass-produced, low-cost housing, though recent policy shifts—such as the 2023 National Green Building Strategy—signal a push toward high-performance timber towers. Yet, China's reliance on imported softwoods and underdeveloped domestic certification systems pose challenges to sustainability. Meanwhile, Brazil and Indonesia, rich in tropical timber, face the dual threat of deforestation and missed opportunities: Chappell documents how both nations could lead in sustainable tropical timber framing but are hamstrung by illegal logging and weak enforcement.
