The Ministry of Education, Culture, Sports, Science and Technology (MEXT) actively promoted Genki as a model of effective language instruction, exporting it through bilateral agreements, teacher training programs, and partnerships with international schools. Simultaneously, private publishers in Southeast Asia, Latin America, and the Middle East began licensing the series, adapting it to local linguistic and cultural contexts while preserving its core listening framework. This globalization was not without friction. In countries with strong national language traditions—such as South Korea, France, and Turkey—Genki faced resistance from educators wary of "American cultural imperialism" or perceived erosion of local pedagogy.
