For instance, Chapter 7, "Data Governance and Privacy Compliance," mandates strict adherence to GDPR, CCPA, and evolving federal standards, reflecting the global regulatory web Comcast navigates. The inclusion of mandatory training modules on algorithmic bias in customer service AI systems underscores the company's push toward ethical AI deployment—a response to public outrage over facial recognition misuse and automated decision-making in service delivery. Equally revealing is the treatment of employee rights and labor relations. Chapter 12, "Workplace Conduct and Conduct Reporting," expands the definition of "unprofessional behavior" to include digital conduct—social media posts, email tone, and virtual meeting etiquette—signaling a blurring of personal and professional boundaries in the remote era. This reflects Comcast's attempt to project a modern, digitally fluent culture while managing reputational risk.
