In contrast, in parts of Sub-Saharan Africa and Southeast Asia, implementation remains pilot-stage, constrained by infrastructure gaps and competing health priorities. Yet even in these contexts, MPFL's influence is palpable: it has set a benchmark for how rehabilitation can be financially and structurally embedded, inspiring regional adaptations such as India's "Functional Recovery Code" and Brazil's "Reconstrução Mobilidade" initiative.
