These capabilities, however, demand technical expertise and ethical guardrails—particularly regarding privacy and consent. Environmental science has similarly embraced mixed methods. Satellite remote sensing tracks deforestation and glacial retreat, while community-based monitoring integrates indigenous observations into climate models. Projects like the Global Forest Watch combine machine learning with on-the-ground data, illustrating how technology and human insight can strengthen ecological accountability. These sectoral transformations reflect a broader shift: research is no longer siloed but networked, iterative, and adaptive.
