The 2008 financial crisis accelerated this collapse: trust in institutions eroded alongside stock markets, and advertisers fled to digital platforms with lower accountability. By 2015, 40% of major newsrooms in the Global North had shrunk by more than half since 2000, according to the International Press Institute. Marquez framed this not as a business failure, but as a civilizational shift: when profit over purpose, journalism became a derivative service, chasing clicks rather than truth. The technological revolution amplified both opportunity and peril. The rise of data journalism allowed deeper analysis—Marquez herself pioneered cross-border collaborations using leaked datasets like the Panama Papers and Pandora Files. Yet, the same tools that enabled investigative breakthroughs also empowered state and non-state actors to manipulate discourse. Deepfakes, algorithmic amplification, and coordinated troll networks turned the information environment into a counterfeit reality. In her analysis, the last lecture was no longer confined to a single speaker; it was a recurring motif—each journalist, in their final act, warning of systemic vulnerability. Expert perspectives were woven throughout. Looking ahead, projections suggest a bifurcated future. In stable democracies, a new paradigm may emerge—one where journalism is decentralized, secured, and integrated with civic infrastructure. In Ukraine, 2004, Marquez documented how oligarchs laundered billions through shell companies, hiding assets

behind layers of legal opacity. The *Pandora Papers*—revealed a decade later—echoed these early revelations. Yet, unlike the earlier era, the final exposés were often delivered not in polished reports, but in hastily encrypted messages, archived in secure servers, accessible only to trusted collaborators.
