But within weeks, similar anomalies appeared across energy grids in Texas, rail networks in Germany, and pipeline operators in Nigeria—all linked by a common thread: outdated software patches, ignored compliance protocols, and cascading human-machine errors. No single report captured the full scope. A coalition of investigative journalists from The Global Risk Review, alongside a former NASA software engineer turned open-source advocate, recognized a systemic pattern. They began manually cross-referencing incident reports, FAA and OSHA filings, and internal company memos—a laborious process that revealed over 800 unreported failures in under two months. Frustrated by the absence of a centralized, machine-readable database, they proposed a platform that could aggregate, verify, and visualize such data. Launched in June 2013 under the name Accidentsketch, the prototype was a static wiki hosted on a peer-to-peer server, powered by MediaWiki and enhanced with basic geotagging. It listed 1,200 incidents, annotated with source URLs and timestamps. But its true innovation lay not in storage, but in design: each entry included a risk score, causal chain diagram, and a warning about jurisdictional blind spots. Within months, academic researchers in engineering safety and public health began citing it. By 2014, the platform had attracted attention from the International Labour Organization, which used its data to support a policy brief on automation risks in manufacturing. The early years were marked by technical and philosophical challenges. How to define an “accident”? Should near-misses count? How to handle proprietary data that was only partially disclosed? The founders adopted a strict inclusion criterion: incidents must be documented in public records, regulatory filings, or credible investigative reports. This commitment to verifiability became Accidentsketch’s hallmark. Technically, the shift to a dynamic database in 2015 marked a turning point. Developed with open-source tools like PostgreSQL and Leaflet.js, it enabled real-time updates and interactive maps.
