The company commissioned a series of ethnographic studies, employee sentiment surveys, and comparative labor law analyses to ground policy development in both data and lived experience. The 2024 handbook was thus born not from boardroom mandate alone, but from a deliberate effort to institutionalize a more adaptive, context-sensitive approach to workforce governance. It marks a departure from the "one-size-fits-all" model that had long characterized Costco's global operations, replacing it with a "glocal" framework—global principles adapted to local realities.

The geopolitical backdrop was equally formative. The handbook introduces a multi-tiered grievance system: first-level resolution via store managers, escalation through regional HR liaisons, and independent third-party mediation for unresolved cases. It also establishes whistleblower protections modeled on the U.S. Sarbanes-Oxley Act but adapted for frontline workers, including anonymized reporting channels and anti-retaliation assurances.

Training protocols are detailed and mandatory. Yet the handbook's rollout was not without friction. Labor advocates praised its ambition but criticized its reliance on local implementation, warning that cultural resistance or weak enforcement in some regions
