The 1962 Nobel Prize, awarded to Watson, Crick, and Wilkins, excluded Franklin—her passing in 1958 barred by the prize's posthumous restriction—yet her legacy now informs broader debates about credit, collaboration, and ethics in science. The double helix also catalyzed profound philosophical and cultural shifts. For the first time, life was describable in molecular terms—genes as discrete, replicable units encoded in a polymer of nucleotides. This reductionist framework
