A 2021 audit of 500 global health MCQs found that 68% were developed in high-income countries, with only 12% incorporating input from field workers in

endemic zones. Questions often use clinical terminology unfamiliar to community health workers in rural areas, or assume assumptions—like universal access to clean water—that do not hold in many regions. This creates a feedback loop: poor training leads to weak surveillance, which in turn reinforces the need for flawed MCQs. The Coalition for Epidemic Preparedness Innovations (CEPI) has funded pilot projects integrating MCQs into national training curricula in Indonesia, Kenya, and Brazil, using adaptive algorithms to tailor difficulty and language. These initiatives show promise, but scalability remains constrained by funding cycles and bureaucratic inertia. Geopolitically, MCQs have emerged as quiet instruments of soft power.
