African rangers estimate that up to 20,000 elephants are killed annually, not just for ivory but for

bushmeat, skin, and live capture for captivity. Asian markets, particularly China, Vietnam, and India, sustain demand through cultural narratives, despite official bans. This demand reshapes how elephants are managed—often in protected areas turned into tourist attractions where anatomy is curated for spectacle. Elephants at sanctuaries may receive medical interventions, dietary supplementation, and behavioral enrichment, but their natural migratory patterns are disrupted, their social structures altered.
