In contrast, the U.S. approach remains fragmented—relying on sectoral laws and self-regulation, which critics argue enables corporate capture. China’s model combines state-mandated behavioral standards with surveillance infrastructure, using chordal logic to reinforce social conformity. In India, where digital inclusion is expanding rapidly, regulators face a dual challenge: fostering innovation while preventing digital dependency. The Digital Personal Data Protection Act (2023) includes provisions for “transparent algorithmic practices,” but enforcement remains nascent. Meanwhile, in Latin America and Africa, mobile-first platforms have adopted localized chordal strategies—tailoring behavioral triggers to cultural rhythms, linguistic patterns, and communal values. These adaptations highlight the global reach of the model, yet also expose unequal power in its deployment. The chordal system thus became a flashpoint in the broader contest over digital sovereignty—where control over human behavior equaled control over society.
