instance, hosts digital libraries with printable PDF practice sheets featuring Thuluth and Diwani scripts, designed to engage youth in heritage preservation. These initiatives align with broader regional agendas: leveraging cultural assets to diversify economies beyond oil, and to assert intellectual independence in a globalized world. Japan's approach reflects a different dynamic—one rooted in aesthetic continuity and linguistic pride.
