no real-time monitoring. When a 2022 rip incident occurred in a resort-adjacent cove, the lack of public alert systems led to a 45-minute delay in rescue, drawing international criticism. The geopolitical challenge is not technical, but institutional. Effective response requires interagency data sharing, standardized communication protocols, and sustained public investment—elements often missing in regions where coastal risks are growing but governance lags. The UN Office for Disaster Risk Reduction (UNDRR) has flagged this as a “systemic vulnerability,” urging low- and
