The global context deepens this dynamic. In Australia, similar critiques emerged around films like **Rabbit-Proof Fence** (2002), where non-Indigenous directors were accused of co-opting trauma. In New Zealand, Waititi’s **Hunt for the Wilderpeople** (2016) demonstrated how Indigenous sensibility could thrive within commercial frameworks—but raised questions about scalability and industry gatekeeping. Governments and institutions in Canada, the U.S., and New Zealand have begun funding Indigenous media initiatives—Canada’s Indigenous Screen Office, for instance, has allocated over \$200 million since 2018—acknowledging media’s role in reconciliation. Yet structural inertia endures. As media economist Dr. Aroha Te Pareake Mead notes, “Representation isn’t just about visibility; it’s about power—over funding, distribution, and narrative authority.” The industry’s response has been uneven. Some studios, like Netflix with its Indigenous content partnerships, have expanded opportunities. Others resist, fearing “niche” appeal. The result is a fragmented landscape: mainstream Hollywood continues to treat Indigenous stories as exceptions, while independent and streaming platforms increasingly embrace them as mainstream. This

bifurcation shapes not only what gets made but how authenticity is negotiated.

Expert Perspectives: From Theory to Practice

Scholars and practitioners offer divergent but convergent insights into Reel Injun's legacy. In post-apartheid South Africa, filmmakers such as Zola Mashiloane challenge dominant cinematic myths through films like *Life, Above All* (2010), centering Xhosa youth beyond stereotypes of poverty. Japan’s Ainu community, historically denied recognition, has seen a cinematic resurgence with films like *Ainu: The First People* (2020), produced with Ainu leadership, reclaiming ancestral stories long suppressed. Even in Europe, Roma filmmakers like Željana Zrička (*S.r.o.*, 2018) confront centuries of cinematic invisibility and caricature, using humor and realism to assert dignity. These global parallels reveal Reel Injun as a transnational syndrome—rooted in colonial history, amplified by global media capitalism, and resisted through localized acts of resistance. These tools could democratize production, but require infrastructure investment and digital literacy programs. Institutional reform hinges on systemic change. The growing influence of Indigenous-led film bodies—such as Australia’s Indigenous Film and Television Collective (IFTVC) and the U.S.’s Native American Journalists Association—signals a shift toward self-determination. If supported, these organizations can scale production capacity, advocate for equitable funding, and enforce ethical standards. Yet progress depends on sustained political will and corporate accountability. Generational change is perhaps the most hopeful frontier. Young Indigenous creators—digital natives fluent in both tradition and technology—are redefining storytelling.
