The U.S. Navy's blockade and submarine warfare crippled these supply lines, exposing the fragility of Japan's war economy. In contrast, the U.S. leveraged its vast industrial base and financial power. The War Production Board (WPB) redirected 70% of manufacturing toward war by 1943. Automakers like Ford and Chrysler produced B-24 bombers—over 18,000 by war's end—while steel mills in Pittsburgh supplied armor for both Europe and the Pacific. The WPB's “Victory Production” program standardized parts, streamlined logistics, and

incentivized innovation. By 1944, American industry produced more tanks, planes, and ships than all Axis powers combined. This industrial might was not without human cost.
