His *Suicide** study, a landmark in empirical sociology, demonstrated how belonging to religious, familial, or national groups reduces suicide risk, underscoring society's constitutive power. Durkheim's structural functionalism offered a framework for understanding social order, but critics later argued it underplayed conflict and change. Yet his insistence on studying social facts—external, coercive forces shaping individuals—remains foundational. His work on education, religion, and law revealed how institutions reproduce shared meaning, a lens still vital in analyzing contemporary issues like polarization and misinformation.
