Even non-Western militaries are adapting: India’s Integrated Air Command and Control System now includes modules for T-cell-like coordination, reflecting a global convergence on distributed, networked air operations. While COTS integration lowers entry barriers, sustaining a global network of T cells demands continuous investment in satellite infrastructure, cyber resilience, and personnel training. The U.S. Air Force's 2025 budget proposal allocates \$7.3 billion to Wing T modernization, including \$1.2 billion for AI-driven mission planning and \$900 million for next-gen stealth drones. However, fiscal constraints in allied nations threaten uniform adoption.
