Similarly, the oil and gas sector in Digboi and Golaghat, contributing significantly to India's energy grid, saw their employees—often migrant laborers—navigate bureaucratic hurdles in voter registration. Their inclusion in the list meant amplified political voice; exclusion meant marginalization. From a

methodological standpoint, the 2010 PDF was the culmination of a decade-long digitization and standardization effort. Prior to this, voter lists were fragmented across district-level registries, prone to duplication, omission, and manipulation. The *Voter's List Assam 2010* represented a shift toward centralized, computerized electoral rolls managed by the Election Commission of India (ECI) under the *Representation of the People Act, 1951*. This reinforced the ECI's mandate to prevent "illegal migration" but also entrenched exclusionary norms under legal guise. Legal scholar Dr. Vikram Nath describes the list as "a constitutional paradox: a democratic necessity implemented through mechanisms that risk undermining the very rights it seeks to uphold." Controversies surrounding the 2010 list were immediate and persistent. Opposition parties accused the ruling All India United Democratic Front (AIUDF) of orchestrating selective omissions to dilute opposition strongholds. Civil society groups documented thousands of cases where landless laborers—critical to tea garden and construction sectors—were excluded due to "unverified domicile" or "incomplete genealogical proof." The ECI's response, relying on 2008 delimitation data and cross-referenced with Aadhaar links (then nascent), underscored the tension between technological promise and human reality. Privacy advocates warned that the digitization, while improving efficiency, also risked exposing vulnerable populations to surveillance and misuse. Risks embedded in the voter list extended beyond politics. In districts like Karimganj and Cachar—hotbeds of identity politics—residents faced arbitrary omissions, often due to incomplete documentation. Internationally, Assam’s approach resonates with states managing complex citizenship regimes—from Bangladesh’s *National Register of Citizens* to Myanmar’s ethnic categorization. Yet its democratic framework, with judicial oversight and multi-stakeholder validation, offers a counterpoint to top-down exclusion.
