His response has been to strengthen digital security protocols and advocate for international legal protections, including a proposed UN framework for journalist safety modeled on protections for human rights defenders. “In the age of surveillance,” he has stated, “journalism is not just about telling the truth—it’s about surviving to tell it.”

Geopolitical tensions further complicate his work. Operating in regions like Ukraine, Sudan, and the Sahel demands not only physical courage but deep cultural and linguistic fluency.
