The transition to the WJ IV in 2007 marked a paradigm shift. Driven by advances in neuropsychology and cognitive neuroscience, the revised assessment incorporated dynamic elements: adaptive testing algorithms adjusted difficulty based on performance, while new subtests like *Phonological Awareness* and *Verbal Memory* reflected growing understanding of language development across the lifespan. Crucially, the WJ IV expanded its normative base to include a more diverse sample—though critics argue it remains skewed toward monolingual English speakers.
