In 2023, a coordinated campaign targeting cryptocurrency exchanges—attributed to a loosely affiliated network dubbed “CryptoPhantom”—resulted in over \$2 billion in losses, with no clear attribution. The attackers used AI-generated personas to infiltrate exchanges, manipulate trading algorithms, and liquidate assets before detection. This convergence of cyber capability and financial incentive creates a self-sustaining cycle: the more successful the Ghost operations, the more investment flows into developing more sophisticated tools. Private cybersecurity firms, eager to defend against unseen threats, drive innovation that in turn empowers the Ghost. Meanwhile, state actors monetize these capabilities—either directly, through cyber units, or indirectly, by licensing or leaking tools to proxies. The result is a global ecosystem where influence is not just seized, but engineered, scaled, and monetized.
