Internationally, the gap is wider: in rapidly urbanizing regions like sub-Saharan Africa and South Asia, only 12% of new public buildings comply with international egress benchmarks, according to a 2023 report by the Global Fire Safety Initiative. This disparity underscores a deeper ethical dilemma: while NFPA 101 sets a high bar, its global adoption is
