This recalibration pressures corporate governance toward greater foresight and ethical accountability.

# **Controversies, Risks, and the Peril of Whistleblowing**

Despite its triumph, the Brockovich case exposes enduring vulnerabilities. PG&E's initial response—public denial, legal challenges, and attempts to delegitimize Brockovich—epitomized corporate resistance to accountability. Internal memos revealed a strategy to delay action by casting doubt on scientific consensus, a tactic still observed in industries from tobacco to fossil fuels. Whistleblowers face acute risks. Brockovich herself endured threats, surveillance, and personal strain—emotional and financial—long before legal victory. Legal scholars warn that while the case strengthened protections under the Sarbanes-Oxley Act and similar whistleblower laws, enforcement remains inconsistent, especially for non-corporate actors in public service or marginalized communities. The case also highlights systemic gaps in regulatory oversight. Even after PG&E's settlement, enforcement mechanisms proved insufficient to prevent recurrence.
