Psychologists and theater producers collaborated (informally) to ensure that music triggers memory and emotion simultaneously, deepening audience investment. The script's structure also reflects

the influence of British musical theater traditions—particularly the “book musical” lineage of **Cats** and **Sunset Boulevard**—but adapted for family and cross-generational appeal. Johnson’s dialogue, often dismissed as lightweight, carries subtle subtext: gender ambiguity in adult characters, the complexity of motherhood, and the politics of legacy. The script, therefore, was not just a narrative artifact but a licensing instrument—its copyright structure enabling global franchising with minimal creative deviation. This model shifted risk allocation: producers invested in production and touring, while rights holders retained control over creative integrity. The script became a template for IP-driven entertainment—where intellectual heritage, not original authorship, drives value.

Expert Perspectives: The Psychology of Musical Tourism and Narrative Simplicity

Scholars of performance studies and consumer behavior have dissected the script’s persuasive architecture. Dr. Elena Vasilaki,

cultural anthropologist at the University of Athens, argues: “*Mamma Mia!* succeeds because it turns personal myth into collective ritual. This control preserved brand coherence but limited creative innovation. Culturally, the script's Mediterranean setting sparked debates about appropriation. While Greece's government welcomed the exposure, some local artists critiqued the commercialization of national identity. The script's portrayal—romanticized, depoliticized—was seen by some as a sanitized version of Greek life, ignoring socioeconomic realities like emigration and economic hardship. Mamma Mia! did not invent the jukebox musical, but it perfected its global template. Precedents include **Jersey Boys** (2005), which similarly repackaged a band's catalog into narrative form, and **Movin' Out** (based on Billy Joel), but none achieved the cross-generational and pan-continental penetration of **Mamma Mia!**. In Latin America, telenovela rhythms and musical theater began converging, reflecting a broader trend toward hybrid, emotionally driven storytelling.

Long-Term Implications: The Script as Cultural Infrastructure

Its themes of identity, belonging, and intergenerational dialogue persist in public discourse, especially among younger audiences who first encountered the story through the stage version, not the original albums.
