In construction, they form the backbone of skyscraper heights, yet their deaths—often from falls or heatstroke—rarely trigger investigation. A 2018 ILO report found that in Thailand alone, over 2,000 migrant workers die annually in construction, mostly without compensation or accountability. The geopolitical backdrop deepened this crisis. In Qatar ahead of the 2022 World Cup, reports surfaced of workers dying from heat exhaustion in temperatures exceeding 50°C, with no medical care available. The global demand for “fast” infrastructure—driven by tourism, real estate, and national prestige—externalized human risk onto vulnerable populations. This dynamic is reinforced by financial mechanisms. Supply chains are fragmented across jurisdictions, allowing corporations to obscure liability. A single smartphone, for instance, may involve rare earth miners in the Democratic Republic of Congo, component assemblers in Vietnam, software developers in India, and logistics firms in Dubai—all under layers of subcontractors.
