The British, having established trading posts along India's coast, sought to expand their influence through economic dominance. Meanwhile, Siraj-ud-Daulah, a young and ambitious ruler, aimed to reclaim authority from foreign powers that had eroded Mughal control over Bengal. The struggle for Plassey must be understood within the broader decline of Mughal power after 1707, which created a power vacuum that regional governors like Siraj-ud-Daulah attempted to fill while facing encroaching British interests. The immediate cause of the conflict lay in the Nawab's anger over the Company's fortification of Calcutta without permission after a brief British occupation during the First Anglo-Bengal War (1746–1747). Though the Treaty of Alinagar in 1749 temporarily halted hostilities, it left unresolved grievances. The British, led by Robert Clive, exploited these tensions by forging alliances with discontented Bengali aristocrats, notably Mir Jafar, who resented Siraj-ud-Daulah's perceived tyranny and fiscal mismanagement.
